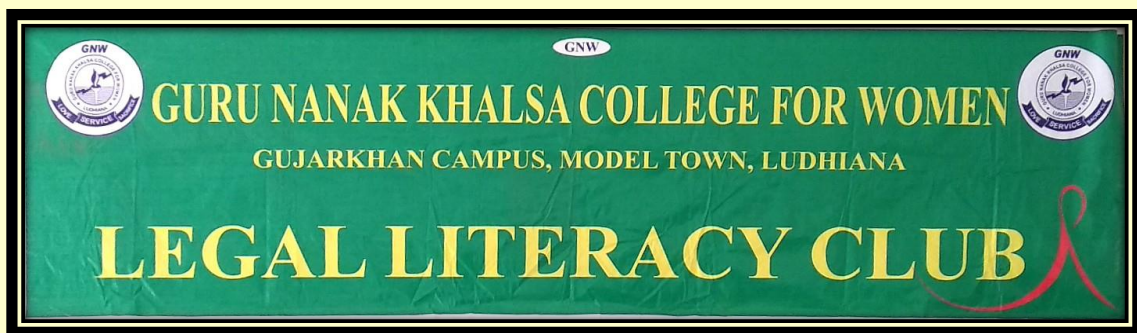
An Overview: LEGAL LITERACY CLUB

Lack of knowledge about the basic legal and civil liberties, human rights, constitutional directives that protect the dignity, liberty and freedom of people manifests itself in the society in the form of problems such as child labour, human trafficking etc., that threatens the safety of all. Due to lack of awareness on the part of women, for whose benefit laws are enacted, ignorance of rights and privileges under the law, they are unable to identify any wrong or injury caused to them as a legal wrong or injury capable of redress through the legal process. Objectives

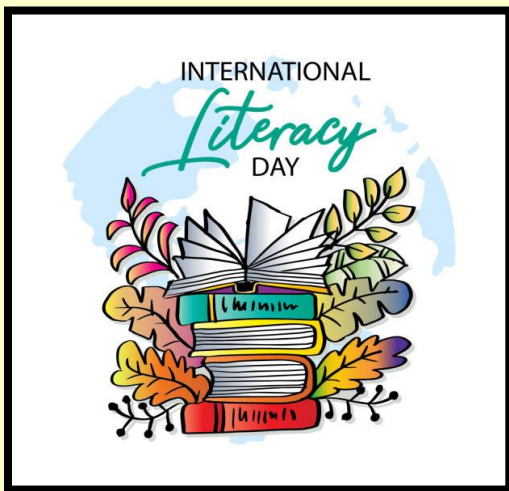
- To Spread Knowledge of the legal rights and duties and to give legal suggestions to the poor and needy for their various problems and for providing Legal Literacy and legal services programmes.



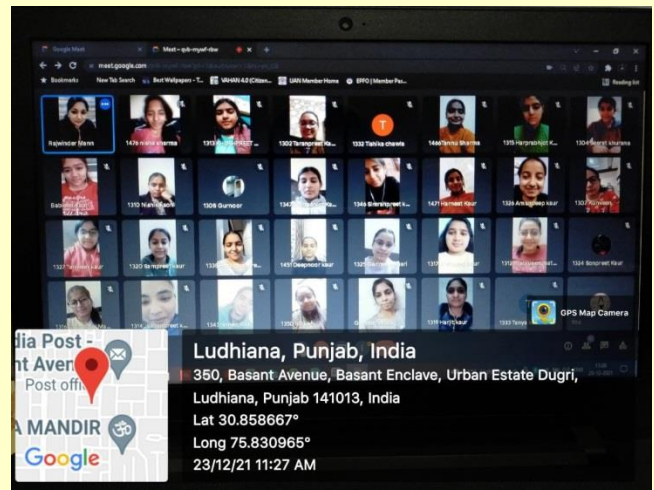
