a. Teachers and Their Responsibilities

Teachers should:

- i. Manage their private affairs in a manner consistent with the dignity of the profession;

- v. Perform their duties in the form of teaching, tutorials, practicals, seminars and research work.

b. Teachers and Students

- ii. Deal justify and impartially with students regardless of their religion, caste, gender, political, economic, social and physical characteristics;
- Inculcate among students scientific temper, spirit of inquiry, and ideals of democracy, patriotism, social justice, environmental protection and peace.

c. Teachers and Colleague Teachers

Teachers should:

- Treat other members of the profession in the same manner as they themselves wish to be treated;
- Speak respectfully of other teachers and render assistance for professional betterment;
- iii. Refrain from making unsubstantiated allegations against colleagues to higher authorities.

 - The students must bring a hard copy of their Admit Card and College ID Card. Entry to the Examination Centre without an Admit Card and ID Proof will not be
 - d. Entry to the Examination Centre will be permitted half an hour before the commencement of the examination (09:00 am, morning session and 01:30 pm, evening session).
 - The students must be seated 10 minutes before the start of the examination.
 - The students coming late should not be allowed to appear in the scheduled
 - The students should not leave the Examination Centre before the halftime is over.
 - h. The students should not carry any material or bags inside the Examination Centre.
 - i. Mobile phones/ Smart watches, Bluetooth, Electronic devices or any other communication devices are strictly prohibited inside the Examination Centre.
 - No trespassing is allowed during the examination.
 - All the students are directed to maintain the decorum of examination and should not be permitted to create any kind of disturbance in the Examination Centre.
