Today, public administration plays a vital role in both developed and developing countries, as the modern state's influence extends deeply into society. It forms the backbone of government, drives social change, and implements laws, policies, and national programs—significantly shaping citizens' daily lives. The effectiveness of government largely depends on how well public administration carries out these responsibilities. In many ways, nearly every aspect of human life is touched by public administration. As an academic field, it has grown in popularity, and the Union Public Service Commission has offered it as an optional subject since 1987. It continues to be a favored choice for students preparing for competitive examinations.

#### INSTRUCTIONS FOR PAPER SETTER AND CANDIDATES:

- Question 1 shall be compulsory question which containing 12 short answer type questions shall be set from the whole syllabus. The student shall attempt any 10 parts in about 25-30 words each. Each part shall carry 2 marks (Total 10x2= 20 marks).


#### ANTI-TERRORISM DAY

### **Constitution Day**


*November 27, 2025*


## Minority Day
